#### I. BACKGROUND:

The Philippine Department of Tourism (DOT) will be participating in the FITUR 2023 in Madrid, Spain. This event will be participated by the Philippine private sector companies, the DOT head Office representatives, performers from the Philippines, and representatives from Congress from January 16-22, 2023

#### II. PURPOSE / OBJECTIVES

The Department of Tourism (PDOT) needs the services of a Madrid-based transportation/tour company that will provide the transport service requirements of the DOT in FITUR 2023 for the transport of PH-based performers, and the PH private sector representatives. It is specifically aimed at the following:

- To provide licensed, road worthy transportation vehicles with licensed driver from January 16-22, 202 for the PH-based performers and private sector delegates;
- To ensure a seamless and smooth implementation of the PH participation in FITUR 2023 including the timely arrival/departure of the PH private sector delegates to the venue and the PH -based performers.
