I. BACKGROUND:

The Philippine Department of Tourism (DOT) will be participating in the World Travel Mart 2023 including the conduct of side activities (BBMG Launching in London, technical inspection of tourism-related conservation sites, etc.) by the members of the House of Representatives from November 5-10, 2023.

II. PURPOSE / OBJECTIVES

The Department of Tourism (PDOT) needs the services of UK-based, licensed transportation service providers that will provide the transport service requirements of DOT-LLU re the PH participation of the members of the HOR in WTM 2023 including the conduct of side activities during the above event.

Objectives:

- To provide licensed, road worthy transportation vehicles with licensed drivers from November 5 to 10, 2023.
- To ensure a seamless and smooth implementation of the above project including the conduct of side activities such as the BBMG, technical inspection of tourism-related conservation sites, etc., meetings, etc.

III. \CAPABILITY REQUIREMENTS

- Must be a London-based/ registered company with duly licensed drivers
- Must have worked with the PE London, PDOT London or other PH government agencies in London
- Must be able to provide the requirements of PDOT London based on the detailed required services
- Must be willing to provide the required services on a send-bill arrangement
